ABOUT SETHU

Based in Goa, India, Sethu is a charitable trust that was established in 2005. It believes that with acceptance and nurturing, all children can grow and develop to their maximum potential. Children are the seeds of a wholesome, healthy and happy society and it behoves each of us to do everything we can to ensure that their unique magnificence comes to fruition.

Sethu is 100% 'organic' - we have grown naturally, in response to the needs of the children who have sought our services. Joy, hope and bundles of energy are delivered at Sethu's doorstep every day! Children come to us in hundreds and bring along their families, teachers, communities. Thus, Sethu is placed in a vantage position to be an agent of transformational change and cultivate a better world.

Sethu's Child Development Centre (CDC)

A quiet working day is a rarity at the Sethu Centre for Child Development and Family Guidance, a lively hub of activity. Children from all over Goa and the neighbouring states are referred for assessment and therapy to the multi-disciplinary team. At present, the centre functions in just over 200 sq. m of space, where around 20 staff members plus an average of 40 children and their families who visit Sethu every day, share delight and determination. The lack of legroom has not stopped us from accommodating the 1151 children and families who reached out to us in 2017-18, with a range of concerns.

Racing with Rohit

The Kamat (name changed) family was desperate for an early appointment. Their son Rohit was about to be expelled from preschool! After a detailed assessment he was diagnosed to have ADHD. The parents were given a behaviour management plan. During a school visit, simple but effective strategies like decreasing Rohit's writing load and giving him short breaks during class work were discussed. However, even after a 6 weeks trial, Rohit's impulsive behaviour caused him to injure one of his classmates with a pencil. In consultation with the developmental pediatrician at Sethu, his parents started him on ADHD medication. The change in his behaviour was rather dramatic. He could focus better and remember what he was told. His parents attended our Sethu workshop, 'From Disorder to Order'. Here we discussed executive functions and how these are affected in ADHD. Rohit learned more about how his brain is like a 'racing car' and what can be done to make the 'brakes' stronger. Today he is excelling in Std 1. Every day before doing homework, Rohit remembers to do a special exercise - he calls it the 'Dopamine Dance'!

Regular therapy and follow up are critical for developmental progress. Unfortunately, life's daily challenges - long distances, busy schedules, a paucity of income, family conflict - come in the way of regular follow-up. These are some reasons shared by families who had dropped out of treatment at Sethu. Though home intervention would be ideal, shortage of staff and funds precludes this at present. However, we have started taking corrective action. With more team members doing first time assessments, our waiting list for appointments for new registrations has shortened. If families miss appointments, a follow-up phone call is made within a week. Phone calls, text messages and email help families and therapists stay in touch. Written therapy programs remind families what they have to do. Sethu has planned to train a cadre of child development workers who can provide basic assessment, therapy and support closer to people's homes. With clients coming from every nook and corner of Goa, this will be a challenge in terms of finding the human and fiscal resources, but as always, Sethu is confident that the generosity of people in our community and the corporate world will bridge this gap.

From Disorder to Order project

The number of children with ADHD referred to Sethu has been steadily increasing. A pattern of 'crisis intervention' is often seen, where families seek help only when the child is in serious trouble. ADHD is a treatable condition that affects a child's behaviour, learning, self-esteem and relationships. In April 2017, the Sethu team initiated a comprehensive programme using a strengths-based and family-centred approach to address the challenges of ADHD. This year we have treated 160 children with ADHD from across Goa. Our activities include developing treatment protocols and training parents, teachers and other professionals. Group training programmes for parents and children have created a community of families who can be advocates for their children. Sethu is very grateful to Pentair Water India Pvt. Ltd, Guala Closures Pvt. Ltd., Mr Muralidharan and Indu Rao for contributing towards this project.

IAP Fellowship in Developmental and Behavioural Pediatrics 2017-18

Sethu was one of nine institutions in India to be accredited by the Indian Academy of Pediatrics to run the one-year Fellowship in Developmental Pediatrics. Dr Aparna Wadkar, from the Pediatric Neuro-rehabilitation Centre at Goa Medical College was deputed by the Govt. of Goa to attend this training. With a passion for her subject, Dr Aparna was the perfect choice to kick-start this important training course at Sethu and she went for gold!

Sethu also offers one-year Institutional Fellowships in Speech and Language Therapy - Mallika Lewis is our first candidate who has excelled in many ways.

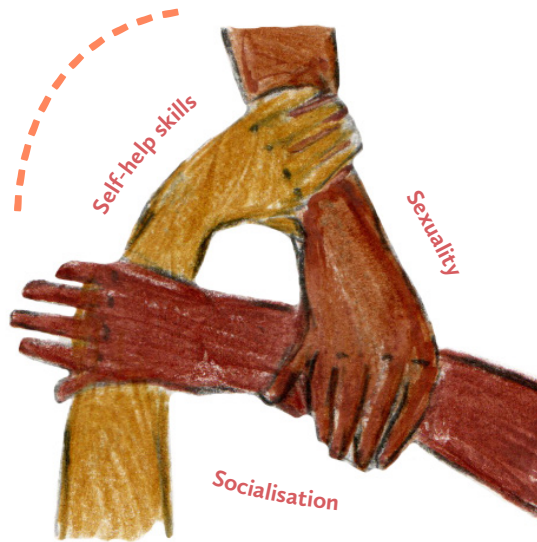
"The IAP Fellowship broadened my understanding of child development and behaviour and helped me to use a family-centred approach. I learned to connect with adolescents, an age group I was not comfortable with due to minimal exposure in my post-graduate days. Sethu centre is a true multidisciplinary centre and scaffolds every child towards successful adaptation in society by building a team around the child. I am definitely going back to Goa Medical College armed with heaps of knowledge and experience."

Working with Families

Sethu can do its work mostly because children have families. Thanks to these many loving hearts and hands, we learn more about children and together find ways to make a change for the better. During 2017 - 18 we conducted a multitude of training programmes for parents, including Asha and Arambh (for families of children with autism) and workshops on discipline, ADHD, childhood sexuality, adolescence and communication.

Caring for children with behaviour difficulties and developmental challenges is not easy. The families often come to us feeling desperate, hopeless and alone. Our first action is to look for strengths. Our first recommendation is usually to ask the parents to look after themselves and do something to 'recharge the batteries' every day.

Children with disabilities are much more likely to be sexually abused. Myths like the 'innocence' and 'immaturity' of children with disabilities lead families to neglect the importance of sexuality education for this population. At Sethu we emphasise that self-help skills, socialisation and sexual development are closely interlinked and are essential for independence and safety. During this year, Sethu conducted four workshops for parents on childhood sexuality, including two in the area of special needs.

Working with Schools

Sethu's commitment to inclusive education stays strong. Tarang – Transforming Schools, a two-year project to promote inclusive education in preschools of Goa, was initiated in July 2017.

Everyone's talking about inclusion but ground realities such as crowded classrooms, unprepared teachers and academic pressures often make it difficult to practice. For over a decade, Sethu has been striving to bring schools on board the 'Inclusion Express'. We have realised that it can work only through close partnerships. We contacted 50 pre-schools that had referred young children to us. 23 schools attended an orientation meeting on inclusion in August 2017. We planned two training programmes targeted at Heads and teachers - a 2-day intensive workshop for Principals and coordinators called 'Educational Leadership for Inclusion' and an 8-month 'Certificate course in Inclusive Education' for preschool staff. 10 Heads/coordinators along with 24 teachers from 11 preschools registered and completed these training modules.

Schools performed a self-audit of their inclusive philosophy, policies and practices and planned a road-map for inclusion for the next 3 years. Orientation lectures on inclusion were also conducted for 15 other pre-schools which had admitted children with special needs.

The Tarang Transforming Schools project is ready to move into the next phase of capacity building and mentorship for 2018 – 2019, where we will journey together with 8 schools on the inclusion road.

Mirror-cles happen!

Hari (name changed) studies in Senior KG and is learning to write the alphabet. His teacher noticed that he often makes mirror image mistakes (e.g. writing 'b' for 'd') whilst writing. At a Tarang training, she learnt about the 'Handwriting without Tears' programme and how to use the 'Wet-Dry-Try' method. Wielding wooden cutouts, a sponge and his slate, Hari now remembers that he has to start at the star. He enjoys practising the letters and loves to write the names of his friends.

Gnyandeep

The Gnyandeep programme aims to create supportive learning environments in Government-run preschools (anganwadis). This year, the training focused on empowering the anganwadi helpers who besides cooking the delicious breakfast, often take on teaching roles. The training facilitated their understanding of child development and behaviour, multiple intelligences and common disabilities. The Sethu team has also been working with the anganwadi teachers to help them identify their strengths and supports, analyse the challenges they face and reflect on how they can find solutions to these problems.

During 2017-18, INR 1,55,550/- was spent on child sponsorship.

When many heads and hands come together, every problem can be solved. Akash's parents did not believe this at first. Parenting their 9 year-old son with autism was an insurmountable burden. Weighing in at 50 kgs, Akash was stronger than both of them. Not getting what he wanted triggered a meltdown. His parents were desperate. They approached Sethu and thanks to a most generous sponsor, Akash's multidisciplinary therapy fees for the next 5 years were taken care of. For the first time, his parents felt like they had a real family. The therapists worked on Akash's communication and sensory needs and today he can tell people what he wants by using an Alternative Augmentative Communication device. He attends a special school during the day and travels by bus. Akash loves music and after he has complied with the therapist's instructions, he grooves to Bollywood beats.
